

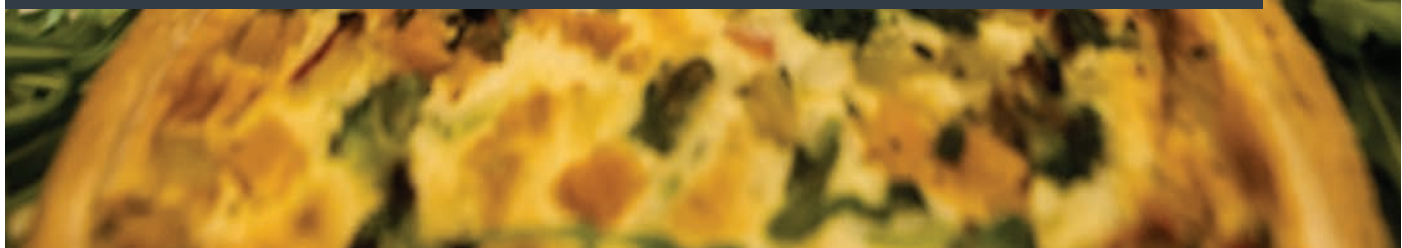

With the enactment of the EU Food Information for Consumers Regulation (EU FIC), there's a whole host of allergen information you now need to provide for your customers... but how are you managing to keep it all up-to-date and accurate? Are you relying on hand-written notes and lists? And frankly, can it be a bit of a nuisance?

Legislation & The Law

The EU Food Information for Consumers Regulation No. 1169/2011 now requires all food service organisations serving unpackaged food or food packaged on site for immediate consumption to supply details of all items which contain the EU 14 major allergens.

You have to list a breakdown of allergens for each item/dish in an obvious place such as a menu, chalkboard or product information card; or indicate clearly that the information is freely available from your staff.

And you need to have a written version of item-specific details available to your customers if they ask for one.

The Zebra Food Safe Card Solution System can do all that, in just a few quick and easy steps... producing a branded plastic card, complete with all the appropriate information, in no more than 10 seconds!*

Our cards are tested to Commission Regulation (EU) No 10/2011 (14 January 2011 with amendments); the ribbons meet EC 1935/2004 and are ISEGA approved for use on food safe cards.

*Per double-sided monochrome card; single-sided monochrome cards take approximately 5 seconds to print.
